BOARD GUIDELINES

The Extra Credit Show Board of Directors should be as diverse as our nation. Our members are of good moral character, highly qualified in their skill set, and passionate about the education of our nation’s K-12 population. They have a depth of personal and professional experience and a broad understanding of the work involved and the goals that are strived for by the organization.

Board members have a vested interest in helping to promote a changing of the conversation about education in America away from the present negativity to one that encourages and empowers others to see and adopt what is working in K-12 education. They fulfill this challenge through several means. They oversee the creation and adherence to company policies and publicly assure the financial strength, integrity and stability of the organization. They create, implement, and participate in a development plan that includes fundraising through personal and professional financial gifts and/or gifts of time, talent and energy, annual appeals, and specific program involvement. They make personal introductions to the Executive Director of community leaders who can connect the organization to foundation, corporate and local business financial support. They also introduce the Executive Director to educational influencers and innovators and assist with inviting them to be guests on the show and assist in the promotion of their episodes. In short, board members are the personal connection to those in their community who want to bring positive awareness to K-12 education.

Governing excellence requires members who can think conceptually and do so with a long-term perspective, being able to welcome a diversity of opinions gracefully and abide fully by group decisions. They must be able to:

- Speak from an organizational perspective rather than from their own or from a sub-group perspective
- Avoid conflicts of interest
- Avoid voting on issues they are not educated about
- Place organizational accountability above personal interests
- Be able to view the Board’s task of assuring performance is at arm’s length through setting expectations, delegating to the Executive Director and monitoring activities.

Board Members Responsibilities and Requirements

In addition to attributes of good character, the participation/continuing participation as a board member requires:

- Alignment with mission
 - Planning, supporting, and voting according to the mission
 - Act in good faith with a duty of care and loyalty to the organization
 - State for the record any conflict of interest that may arise and recuse themselves if necessary
 - Recuse themselves from discussion and voting on matters one is not well-versed in
- Expertise
 - Members should bring valuable expertise in one or more aspect of the organization's operations such as corporate development, public or government relations, fundraising, business management, technical operations, podcasting, marketing, education innovation, student, teacher, school administrator, or parent perspective, etc.
 - Political opinions are NOT welcome when representing **The Extra Credit Show**
- Attendance at meetings
 - Two no show/no calls or three missed meetings in a calendar year is considered a resignation
- Assurance of organizational, financial and leadership responsibility
 - Accept fiduciary responsibility for the organization
 - Monitoring the operational budget and financial stability of the organization
 - Developing and actively pursuing fundraising goals and initiatives
 - Assuring that IRS, State reports, annual audit and all other financial records are in order
 - Hiring, evaluation, counseling, monitoring and support of the Executive Director
- Assurance of board effectiveness
 - Must be eighteen years of age or older
 - Must not be related to any other board member* (exception: Initial board)
 - Be active in the board development program
 - Understand role of board membership
 - Oversight of program in general and not the day-to-day activities
 - Executive Director is the only board employee.
 - All other employees are employees of the Executive Director
 - Develop short and long term plans and priorities
 - Determines, enforces and supports policy and programs
 - Promote the well-being and continued growth of the organization
 - Maintain positive, respectful relationships on the board in spite of different ideologies
- Board Committees – Chairs will report to full board at each meeting
 - Executive Committee
 - Finance Committee
 - Governance Committee (Policy, procedures, adjudication, elections, perpetuation)
 - Marketing and Public Relations Committee
 - Advisory Committee / Advanced Class Council
